Statement of Purpose

The Dred Scott Heritage Foundation is founded on three principal goals:

Commemoration

Education

Reconciliation

The first two are simple and clear. From the beginning, it was always understood that what reconciliation would be is what God says it is.

It is therefore incumbent upon us to make it so. This workshop was born out of a Dred Scott Reconciliation Forum held in 2012. Retired U S Marshall Robert Moore participated and is in an ongoing mission to share the histories of the Black US marshals and partner from time to time with the DSHF.

He and his organization offer an educational opportunity to better know our rights during these difficult days in Ferguson, MO in order that we can exercise our constitutional rights of freedom of assembly, freedom of speech and self defense while respecting our community and ourselves. Respect and accountability go both ways.

We are grateful to the **National and Lincoln Land Chapter of N.O.B.L.E.** For traveling here for the purpose of sharing with our community, especially those who, through justifiable grief and anger, MUST express the frustration and need for change at the many deaths of young people whose lives have been cut short through violence of every sort.

Dred Scott is symbolic of denied personhood and God-given civil and natural rights. Through the various methods of rebellion, there are things we all need to know to express this in a way that allows your safety, your rights to be exercised and change to occur.
